The two nominees left the room, after voting by attendees, Wendy Quinn elected.

Notice of Motion (1) Submitted by Peter Bullen [Mandurah]

“At State Championship Events where a division is played on a single sheet, that any tiebreakers to determine 1st and / or 2nd place, consist of a ‘Best of’ format consistent with the format used in the round robin phase as opposed to the current single leg format.”

Karen Fleming noted that this would be difficult to do if 3 or more players were to play off. Heather Knoblauch agreed, this would be unworkable.

Wayne Battersby suggested a one leg knockout format in the event of more than 2 players needing to play off. It was then agreed this would not meet the initial request of the motion put forward.

Darren White moved 'at state events wins are recorded as the number of legs won rather than the previous format of win/loss. This will show a more conclusive result and due to time restrictions provide the required time to complete a best of 3 play off.'

Notice of Motion (2) Submitted by Heather Knoblauch [State Games Coordinator]

After considering feedback from various members and reviewing the performances of recent newcomers, it appears that a more flexible approach could encourage greater participation and fairer competition. Therefore, I suggest introducing an alternative pathway for determining the initial average for new players.

The current default averages for new players, as set by Australian Dart Legends, are 15 per dart for men and 11.66 for women.

I would like to propose the following motion:

1. New Dart Legends WA members without an established average start with 13 per dart for men and 10 for ladies, applying to all club events and State Championships.
2. New members wishing to compete in the National Championship may establish an average by participating in either the State or Club Singles Championship. Alternatively, they may elect to accept the default average as determined by Australian Darts Legends.

After discussions, all attendees agreed.

GENERAL BUSINESS

From correspondence.

1. Peter and Annalina of Olympic Darts have expressed an interest in providing their dart supplies at State events. It was necessary for them to do so at one event as Jim Welch was unwell and unable to attend two events. Glenn Duffy also assisted with dart supplies. They thanked the state committee for approaching them and hoped they could be utilised further in 2026.
Trish Butcher suggested that as we have four state events a year, that 2 events get allocated to Olympic Darts and Jim Welch each year.
After discussion, a letter is to be written to Jim Welch to ascertain his future involvement and provide information that Olympic Darts has expressed an interest in providing the service.
2. Bunbury Men's Darts email from Neil Hatchett to purchase 8 stands from State Legends. The WA State Legends have a total of 44 stands – 20 at the Italian Club, Bunbury and 24 at the Dalmatinac Club, Spearwood. It was agreed to sell 8 stands to Bunbury Mends Darts for a sum of \$500.00. Trish to email Neil.

Alley welcomed Coastal Darts Association to the Legends membership. Hosea Namana is the inaugural President with Cath Melia the Secretary. The monthly meets have been scheduled for Saturdays and will alternate between Jurien Bay and Dongara.

Alley spoke about players walking out or not returning to state event without good reason (e.g. illness or family emergency). This is unfair on players in the same division and Heather needs to attend to a redraw.

It was agreed by the meeting that the member's club executive would be notified, and they will be banned from playing in state events for a period of 12 months.

Alley provided information from the Nationals AGM – The opening ceremony from 2026 will not be ticketed, will be free & no food will be provided by the host state.

Alley told the meeting of the need to repair the shipping container storing the dart stands at the Dalmatinac Club, Spearwood. Wayne York noted it was leaking earlier in the year and with the consistent rainfall it has been hard to attend to the repairs. Both Wayne and Rob Hawkins had attended to some makeshift repairs. Rob and Ray Gittos will be completing the repairs in a weeks' time. The state committee agreed to pay these gentlemen \$500 to cover expenses and some money for their time and effort.

Rob Hawkins suggested that any new uniform designs for WA State Legends shirts to incorporate the Australian Flag.

Lou Cherrington acknowledged the lack of attendees and recommended scheduling at a time more suitable to the membership.
